- You indemnify Wellington SPCA against any loss that may incur if a debit order is reversed or not honoured.
- If the bank account holder is a third party legal entity, a copy of the resolution of the authorised signatories are required before any transaction is processed.

**\* Please note that bona fide monetary donations qualify for an 18A tax certificate and entitles you to a tax deduction in respect of your donation. Donors who are South African taxpayers are entitled to deduct the total value of their donations to 18A approved organisations, like Wellington SPCA, in any tax year, up to a limit of 10% of their taxable income for that tax year. \***
